##### Order Description

##### **An Assembly License to Equip Cranes with LMLD**

##### **License Requirements:**

A License for the Electronic Lifting Moment Limiting Device LMLD in Fassi cranes manufactured by an Italian company.



The device is required to have the following functions:

- monitoring pressure using pressure transmitters;
- position control of a crane arm with an electronic angle sensor;
- blocking and allowing only for proper movements depending on the value of the above data;
- a control panel and a display screen for showing information on crane operation status;
- an emergency steering mode.

***The Ordering Party requests the offer presentation regarding the above-stated license, including technical data, as shown above, or their equivalent.***
